

ABOUT CHRIST UNIVERSITY



CHRIST (Deemed to be University) was born out of the educational vision of St Kuriakose Elias Chavara, an educationalist and social reformer of the nineteenth century in South India. ABOUT 2nd SLCUCTAC



The Litigation Committee of the School of Law, CHRIST (Deemed to be University), is proud to host the 2nd SLCU Civil Trial Advocacy Competition 2025-26. The 2nd Civil Trial Advocacy Competition aims to encourage excellence in civil litigation. It provides an opportunity for participants to enhance their skills in case analysis, witness examination, and persuasive argumentation by simulating real-world civil cases. This competition is open to students pursuing a three-year or five-year Law Degree Course in Universities/Colleges/Law Departments in India, as recognised by the Bar Council of India. The competition will be held from 28th August to 30th August, 2025 and will be conducted offline at the Central Campus, CHRIST(Deemed to be University).

Engaging in simulated civil trials, students will have the chance to refine their advocacy skills, legal research, and courtroom etiquette in a realistic setting. Esteemed legal professionals will be participating in the event, offering valuable insights and feedback to enhance the educational experience for all participants.

INSTRUCTIONS OF THE COMPETITION

- **ELIGIBILITY :**

The competition is inclusive and welcomes participation from all students currently enrolled in either a three-year or five-year Law Degree Course at universities, colleges, or law departments across India. Only one team per college/institution/university shall be allowed to participate.

- **VENUE :**

The 2nd SLCU Civil Trial Advocacy Competition in Bangalore Central Campus. It will be held from 28th August to 30th August 2025. It will be held offline.

- **TEAM COMPOSITION :**

Each team shall consist of three members. Among three members, two members shall be designated as speakers and one member shall be designated as the researcher. Researcher shall also be acting as a witness and no roles can be interchanged after the registration. No change in the team shall be entertained after the completion of registration.

- **DRESS CODE :**

The dress code for all participants throughout the competition shall be:

Men: White shirt, black blazer, black trousers, black tie and black shoes

Women: White shirt/kurta, black blazer, black trousers and black shoes.

- **OFFICIAL LANGUAGE:**

English will serve as the official language used throughout all phases of the 2nd SLCU Civil Trial Advocacy Competition.

INSTRUCTIONS OF THE COMPETITION

- PROCEDURE FOR REGISTRATION:

Participation in the 2nd SLCU Civil Trial Advocacy Competition 2025 is restricted to 20 teams only. Institutions/Teams interested in participating in the Competition will have to provisionally register by filing the form given below and only after confirmation of the provisional slot by the organizers, they should complete the formalities of the final registration. The slots shall be reserved based on a 'first come' basis for the first 20 teams.

- LINK FOR PROVISIONAL REGISTRATION :

The teams should register through their respective official college Email ID or any other recognized student committee Email ID. Once the teams have provisionally registered, then the teams will be sent a confirmation mail providing them with the link for the Final Registration. Kindly note that only one team per College/Institution/University shall be permitted to take part in the Competition. Kindly check the Timeline of Events given in the brochure for registration dates.

- REGISTRATION FEES:

The registration fee for the Competition is Rupees Three Thousand Only(INR 3000 including GST). It is only payable in favor of CHRIST (Deemed to be University) University, Bangalore. The fee is payable at the time of final registration (Non-refundable). Accommodation arrangements are not provided by the Litigation Committee. Participants are expected to make their own lodging arrangements.
